I/we understand that football & cheerleading is a huge commitment and agree to take such commitment seriously by having my child(ren) at practice and games on time. I/we understand that our child(ren) can be removed from the roster for 2 unexcused absences. I understand that the league does not furnish the following items and that it is the parent's responsibility to do so in-order for the cheerleaders to participate: cheer shoes, tights, socks, turtleneck, bloomers and hair accessories. All of the aforementioned items are chosen by the leagues cheerleading coordinator and are not all inclusive & subject to modification at the discretion of the league. I understand that the league does not furnish football players with cleats, 7 piece pad sets, practice or game pants, or mouth guards. All mouth guards must conform to NFHS rules.           

I understand that it is my responsibility to have a physician perform periodic physical examinations (every 1 to 2 years) on my child(ren) and if any medical condition exists, to obtain his/her physician's consent before allowing my child(ren) to participate in JCYFCL.           

I assume all risks and hazards incidental to participation in cheerleading or football related activities. I waive, release, and absolve the JCYFCL, PYFCO, Williamsburg-James City County Public Schools, James City County Department of Parks and Recreation organizers, coaches, supervisors, sponsors, and participants from any incidents that may occur.           

By submitting this registration, I understand that every parent is required to support the league by working in the concession stand for 1-2 sixty minute shifts or assist on the field during game day as well trash pick up, etc. per child. There is no opt out fee for volunteering; everyone is expected to do their part. Any parent that does not fulfill this obligation will have their child benched for 2 games and/or up until that obligation is fulfilled.           

I understand that a Parent's or "assigned guardian's" attendance is mandatory at all practices and during every game. At least one parent, family friend, or guardian is required to accompany participants at practices and games in case of an emergency or early cancellation. I also understand that the County requires JCYFCL to notify the authorities in the event a child has been left unattended or without a parent available to pick them up at the conclusion of a practice or game.           

By submitting this document you are acknowledging that you have read this document carefully, understand and agree to adhere to its contents, and all information provided by you is correct. Also, you and the participant(s) agree to adhere to the By Laws, Standards of Conduct, Code of Ethics, and the policies of the PYFCO and JCYFCL, available at [www.jamescityjaguars.org](http://www.jamescityjaguars.org).             
In addition, your submittal signifies that in the event of an emergency, you give the JCYFCL permission to provide emergency medical treatment or have your child(ren) treated at a medical facility.
